On-Site Assessment Pricing

The costs of performance of on-site assessments (a three or four day audit-style process involving two or three days spent with the auditor on-site) are covered by the SEQual scheme itself.

Assessment certificates issued by other oil and gas certification schemes are accepted until their expiry, or 1st May 2022, whichever is the earlier. Please refer to the SEQual website for more details.

The following costs are payable by Suppliers as part of the assessment process:

On-site Assessment (basic or advanced, valid for two years)	£480 Assessment Arrangement Fee

The following costs are also payable by Suppliers in exceptional circumstances:

Type of Fee	Price (excl. VAT)
Additional Assessment (where Supplier has added additional codes that require new on-site assessment)	£995 per day plus expenses
Re-Assessment (where the assessment identifies Major Non-conformances)	£995 per day plus expenses

Where the Supplier cancels or reschedules an Assessment within 6 weeks of the Assessment date, the Supplier will be charged the full cost of the on-site assessment (£2,985 for a Basic Assessment; or £3,980 for an Advanced Assessment as applicable, excluding VAT).
